## Exhibitor Terms & Conditions

IT IS AGREED BETWEEN the Windsor-Essex County Association of REALTORS®, the licensee,  
and \_\_\_\_\_ as the EXHIBITOR, herein that:

1. The Windsor-Essex County Association of REALTORS® grants the EXHIBITOR the privilege to use exhibit space at the Ciociaro Club of Windsor 3745 N Talbot Rd, Oldcastle, ON N0R 1L0, during the Trade Show on Tuesday, April 30, 2019.
2. All exhibit space is sold in 8' x 10' units. This includes a 6' x 30" table (if so desired) and two chairs. You may bring a full-standing exhibit, provided it will fit into the designated space. Wireless high-speed Internet access is available, if required. Electrical outlets are also available for a fee, and exhibitors are required to bring an extension cord if required. Note: Tables include black linens, clothed "box style." \* PLEASE NOTE THAT YOU CANNOT PASTE/TAPE/POST ANY MATERIALS TO THE INTERIOR WALLS OF ROOM.
3. The EXHIBITOR will pay to the Windsor-Essex County Association of REALTORS®, the total non-refundable exhibit fee, upon signing and delivering this Agreement to the Windsor-Essex County Association of REALTORS®. This fee guarantees the exhibit space.
4. This Agreement is not subject to cancellation by the EXHIBITOR. However, in the event that the EXHIBITOR cannot mount a display in the exhibit area, the EXHIBITOR has the right to assign its contracted space to another exhibitor upon approval in writing from the Windsor-Essex County Association of REALTORS®, subject to all terms and conditions as set out in this Agreement.
5. Final allocation of exhibit booth space shall be at the sole and absolute discretion of the Windsor-Essex County Association of REALTORS®. If the Windsor-Essex County Association of REALTORS® decides that re-location of an exhibitor is necessary to provide a balanced ambience in the exhibit area, then the EXHIBITOR shall abide by the decision of the Windsor-Essex County Association of REALTORS®.
6. The EXHIBITOR will continue their exhibit to their exhibit booth space(s). Once the exhibit floor plan is confirmed, a copy will be sent to the EXHIBITOR in advance of the Trade Show.
7. The EXHIBITOR hereby remises, releases and forever discharges the Windsor-Essex County Association of REALTORS® of and from any liability resulting from the death of or personal injury to the EXHIBITOR, any of its employees or any person visiting the exhibit area and from damages to the property of the EXHIBITOR or any such person which death, injury or damage, as the case may be, is caused directly or indirectly by any act or omission of the EXHIBITOR. The EXHIBITOR hereby indemnifies and saves harmless the Windsor-Essex County Association of REALTORS® of and from any loss, cost, damage or expenses incurred by the Windsor-Essex County Association of REALTORS® as a result of any such death and/or injury to such person or damage to property however caused.
8. The EXHIBITOR hereby indemnifies and saves the Windsor-Essex County Association of REALTORS® harmless of and from any loss, cost, damage or expenses incurred by the Windsor-Essex County Association of REALTORS® in connection with non-compliance by the EXHIBITOR with this Agreement and in connection with any obligation undertaken by the EXHIBITOR thereunder.
9. The EXHIBITOR hereby gives permission to the Windsor-Essex County Association of REALTORS® to publish the EXHIBITOR's name, company name, and contact details on all or any event-related material, and publish images from the event in future promotional documents.
